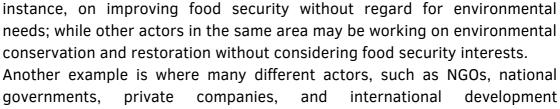

Through in-depth case studies in Ethiopia, Kenya and Uganda we will explore the effectiveness of different governance mechanisms to create interdepartmental, inter-donor, donor-recipient and public-private alignment to improve overall SDG implementation results.

How do mechanisms of cross-level and cross-sector alignment enable development actors to address trade-offs and build synergies in the governance of SDG implementation in Ethiopia, Kenya and Uganda?

#### **Country Focus**

The project focuses on three specific SDGs in three East African countries, and studies their synergies and trade-offs with other SDGs from a governance perspective:

- Uganda (SDG 6 clean water and sanitation)
- Ethiopia (SDG 15 life on land)
- · Kenya (SDG 2 zero hunger)

The research partners in these countries ensure strong embeddedness of the project into local and regional networks.



#### **Planned Activities**

The project design is based on principles of transdisciplinary research, involving stakeholders from different backgrounds and institutions right from the start.

The research is structured around the three in-depth multi-level case studies. Each of these is linked to two PhD projects, looking at SDG interactions from either a global to local or a local to global perspective. A final PhD project focuses on the shared system of rules for aid effectiveness at the international level.



#### **Target Audience**
